Instructions:

- 1) Distribute T1, T2, or T3 resources to students.
- 2) Tell students "We are going to practice calculating "Income," the money you earn and "Expenses," the money that you spend.
- 3) Inform students **"When you earn income, money is added to your account** balance. When you have expenses, money is subtracted from your account balance.."
- 4) Inform students, "Working with your group, you will pick take turns picking income and expense cards." Model pulling a card.. "Based on what the card says, you will either add the amount to your income or subtract it as an expense." Point to columns on student worksheets.
- 5) Tell students "I'll set a timer for 15 minutes. When the timer goes off, we will review our cards and share out answers."

Differentiated Instruction:

- Complete activity whole group so all students are working on the same card.
- Read cards aloud for students who need assistance
- Provide staff support to monitor activity in small groups

Incorporate Bankability:
